TRANSFER OF COPYRIGHT AGREEMENT

Copyright to the above-listed unpublished and original article submitted by the above author(s), the abstract forming part of it, and any subsequent errata, collectively, the "Article," is hereby transferred to the American Alcohol and Drug Information Foundation (AADIF), the publisher of the *Journal of Alcohol and Drug Education* (JADE) for the full term throughout the world, subject to the Author Rights and to acceptance of the Article for publication in JADE. The transfer of copyright includes all materials to be published as part of the Article in any medium, including but not limited to tables, figures, graphs, movies, and other multimedia files in both print and digital formats. AADIF shall have the right to register copyright to the Article in its name as claimant, whether separately or as part of the JADE issue or other medium in which the Article is included.

AUTHOR RIGHTS

The author(s), and in the case of a Work Made For Hire, as defined in the U.S. Copyright Act, 17 U.S.C. § 101, the employer named below, shall have the following rights (the "Author Rights"):

- (1) All proprietary rights other than copyright, such as patent rights.
- (2) The nonexclusive right, after publication by AADIF, to give permission to third parties to republish print versions of the Article or a translation, or excerpts, without obtaining permission from AADIF provided the AADIF prepared version is not used for this purpose, the Article is not published in another journal, and the third party does not charge a fee. If the AADIF version is used, or the third party republishes in a publication or product charging a fee for use, permission from AADIF must be obtained.
- (3) The right to use all or part of the Article, including the AADIF prepared version without revision or modification, on the author(s)' web home page or employer's website and to make copies of all or part of the Article for the author(s)' and/or the employer's use for lecture or classroom purposes. If a fee is charged for any use, AADIF's permission must be obtained.
- (4) The right to post and update the Article on free-access e-print servers as long as files prepared and/or formatted by AADIF or its vendors are not used for that purpose. Any posting made or updated after acceptance of the Article for publication shall include a link to the entry page of JADE. If the author wishes the AADIF prepared version to be used for an online posting other than on the author(s)' or employer's website, AADIF permission is required; if permission is granted, AADIF will provide the Article as it was published in JADE, and use will be subject to AADIF terms and conditions.
- (5) If the Article was prepared under a U.S. Government contract, the government shall have the rights under the copyright to the extent required by the contract. This subsection specifically recognizes and accepts the obligation of an author(s) to upload the Article to PubMed Central(PMC) at NIH where NIH rules and regulations require that the Article be placed in the PMC database.

All copies of the Article made under any of the Author Rights shall include notice of the AADIF copyright.

By signing this Agreement, the author(s), and in the case of a Work Made For Hire, the employer, jointly and severally represent and warrant that the Article is original and the author(s) does not infringe any copyright or violate any other right of any third parties, and that the Article has not been published elsewhere, and is not being considered for publication in any form, except as provided here. If each author's signature does not appear below, the signing author(s) represent that they sign this Agreement as authorized agents for and on behalf of all the authors, and that this Agreement and authorization is made on behalf of all the authors. The signing author(s) and, in the case of a Work Made For Hire, the signing employer, also represent and warrant that they have the full power to enter into this Agreement and to make the grants contained in it.
